Effective Assistance of Counsel. "[T]he right to counsel is the right to the effective assistance of counsel."<sup>333</sup> This right to effective assistance has two aspects. First, a court may not restrict defense counsel in the exercise of the representational duties and prerogatives attendant to our adversarial system of justice.<sup>334</sup> Second, defense counsel can deprive a defendant of effective ...

### **Criminal Practice - Constitutional - Ineffective ...**

To establish ineffective assistance of counsel, the defendant must prove: (1) that counsel's performance fell below an objective standard of reasonableness, 466 U. S., at 688; and (2) that the deficient performance prejudiced the defense, which requires a showing that there is a reasonable probability that, but for counsel's unprofessional errors, the result of the proceeding would have been different, *id.*, at 694.

## **Supreme Court Finds Ineffective Assistance Of Counsel In ...**

1. What is ineffective assistance of counsel in Colorado? Ineffective assistance of counsel occurs when a lawyer does not represent his or her client the way that is expected of a competent attorney. 1 If an attorney’s performance is so flawed that the defendant is deprived of his or her Sixth Amendment right to a fair trial, the defendant may be granted a new lawyer or new trial.

## **Colorado Revised Statutes Title 18. Criminal Code § 18-1 ...**

(1) Notwithstanding any other provision of law, whenever a defendant alleges ineffective assistance of counsel, the defendant automatically waives any confidentiality, including attorney-client and work-product privileges, between counsel and defendant, and between the defendant or counsel and any expert witness retained or appointed in connection with the representation, but only with respect ...

## **Re: The People of the State of Colorado v. Osvaldo ...**

The failure to obtain the advice and assistance of an expert witness can amount to ineffective assistance of counsel under state and federal constitutions, as can the failure to investigate and contact witnesses.

## **IN THE SUPREME COURT OF THE STATE OF ILLINOIS**

Flores-Ortega, 528 U.S. 470 (2000), criminal defendants have a Sixth Amendment right to "reasonably effective" legal assistance. A defendant claiming ineffective assistance of counsel must show: (1) that counsel's representation was deficient; and (2) that counsel's deficient performance prejudiced the defendant.

## **1 102 Ineffective Assistance Of**

Fish, 102 N.M. 775, 777, 701 P.2d 374, 376 (Ct.App.), cert. denied, 102 N.M. 734, 700 P.2d 197 (1985). We hold that Defendant has established a prima facie case of ineffective assistance of counsel on one of his claims and, therefore, remand to the

district court for an evidentiary hearing.

## **Ineffective Assistance Of Counsel In Colorado Criminal Cases**

To prevail on a claim of ineffective assistance of counsel, a petitioner must demonstrate both that: (1) his or her counsel's performance was deficient, and (2) the petitioner was prejudiced by the deficient performance.
